Place, time and method of the bid opening

The public opening of bids will take a place at the premises of the CLINICAL CENTER OF SERBIA – Administrative building, Pasterova St. No. 2, Belgrade.

The bids shall be opened immediately after expiry of a deadline for the bid submission i.e. on the same day 09.04.2019, starting at 09:15 a.m.

Conditions under which representatives of the bidder may participate in the bid opening procedure:

Representatives of bidders who wish to participate actively in the public bid opening must have an authorization to participate in the public bid opening, which must have its own number and date and also must be signed and stamped by authorized person of the bidder.

The deadline for making a decision:

The decision on awarding the contract will be made within 25 days from the bid opening, except in especially justified cases, such as extensiveness and complexity of the bids, or the complexity of the methodology to assign weights, when deadline may be up to 40 days from the bid opening.
